### Video Production

#### Conduct a Pre-Video Shoot Meeting

- Decide when and where to shoot videos pay attention to possible background clutter and noises
- Go over what to wear and what not to wear, changing wardrobe.
- Go over scheduling
- Talk about what not to do to prepare for the video shoot (No scripts, no memorization or no teleprompters)
- Content mapping decide what questions to answer
- Assign questions to individual attorneys
- Talk about how to structure a good answers



### How to structure good video answers


- Rephrase the question into a statement and tell a little bit of a story to set up the answer. (This allows the questioners part to be edited out.)
- Then give as much information as possible.
- Here is an example of a good set up and answer.
- "The other day I received a call from a person that
  was seriously injured in a car crash. Unfortunately
  they weren't able to work and they wanted to know
  how long a car injury claim could take to be fully
  resolved. This is what is important to know about
  how long a car injury claim could take to be fully
  resolve in insert your geography ... (and then give
  your answer)"
- After the set up, the key is to give as much information as possible.
- If the answer is complicated, tell them why it is complicated.



## Deciding What To Talk About

#### What is Content Mapping?

- Content mapping is a way of identifying and organizing what you want to talk about.
- These are your video and blog opportunities.
- The best way to do this is to identify all your legal practice areas and/or the legal issues your support.
- Next, think about your consults about these specific legal issue.... What do your client ask you? or what points do you bring up?
- End Result: A long list of questions organized by practice areas.



- We recommend a large padded interior bag with plenty of space to store all your camera gear.
- We prefer using the Canon 100DG Digital Gadget bag because of the padded dividers and the three exterior zipper pockets for added storage.

#### Video Editing Computer

- If you are looking to create high quality videos <u>quickly, and efficiently</u> then you will need a computer that has processing power, storage space and screen size.
- Look for computers with -
  - Multi-core intel processors (18-56 Cores)
    - > Ex. AMD Threadripper 1920X CPU
  - 16-32 GB of Ram
  - Dedicated Graphics Processing Unit
    - Ex. AMD Vega GPU
  - 1-2 TB Solid state drive
    - > Ex. Samsung 960 EVO Series
- Desktop computers are best to use over laptops. This is due to the large internal drive space and the ability to have several large monitors connected.
- We recommend purchasing a custom made computer from a professional PC builder or through a reputable online store that specializes in video editing computers.

## Video Editing Software

- In order to edit your videos into final educational content, you will need to choose a nonlinear video editing application.
- Free video editing programs can come pre-loaded on newer computers.
- We recommend using Adobe Premiere to edit your videos. This program gives you the ability to edit with greater speed and precision. Premiere also works seamlessly with other Adobe products that you will need like Photoshop and Illustrator.

#### **Importing Video Footage from Camera**

- After installing Transfer Utility, which is the camcorder's software on your computer, connect your camera to your computer by using the mini USB cable.
- After turning on your camera, press the Camera/Play button to switch to playback mode.
- Select [ALL (for PC only)] on the LCD screen. Once the computer and camera make a connection, Transfer Utility will start up automatically.
- Click [Video file import] to start transferring your files into your project folder.

#### **Adding Video Footage to Premiere**


- Once you have a new Premiere file open, you can import video files in two ways.
- The first way is to add video files is to drag and drop your video files into the Media Browser in Premiere.
- The second way is to Choose File then click Import. You can select multiple files or select an entire folder.
- Once you import the video files you will need to wait for the videos to "conform" before
  you start editing. You will see the status in the bottom right hand corner of Premiere.
  This can take several seconds to minutes depending on the size and length of your files.


#### **Editing Video and Exporting Final Product**

Click play on the video to the left and start learning how to edit educational videos step-by-step.

#### **Transcribing Videos**

- By transcribing your videos you can use the spoken words to create good written
  educational web content.
- You will need to listen to each video and transcribe them into text.
- Make sure you format the text so it no longer reads as spoken text, but written text.

#### Creating a YouTube Account


- 1. Sign into YouTube with your Gmail account by clicking the user icon at the top right of the screen.
- 2. Click back on the <u>user icon</u>, and select <u>creator studio</u> (gear icon).
- 3. Click on <u>create a new channel</u>. (Image a)
- 4. In the small text area, click <u>use your law firm's name</u>. (Image b)
- 5. Add your brand name and click <u>create.</u> (Image c)



## Customizing Your YouTube Channel


- 1. Click on <u>customize channel.</u> (image a)
- 2. Click add a background by using an image that is 2560 x 1440 pixels.
- 3. Add a profile icon using an image or logo that is minimum 350 x 350 pixels.
- 4. Click <u>about</u> on the gray horizontal menu bar and select <u>channel</u> <u>description</u> to enter a description about your practice. (image b)
- 5. Finally, add your email for business inquiries, select your country location, and add custom links (website, blog, social media, mobile app). (image c)






## Uploading an Optimizing YouTube Videos

- 1. Start uploading your videos by clicking the arrow up button on the top right of the screen.
- 2. Start dragging the videos you want to upload onto the screen.
- 3. Add your title, description, and your keywords.
  - 1. Your **title** should be very simple and to the point
  - The first 200 characters of your **description** must be enticing to generate views. We highly recommend adding the transcription of your video after your opening video description. We also recommend adding links to your website, practice areas, and your phone number.
  - Use keywords of the location, type of practice, type of legal issue, and other related keywords.
- 4. Select your video icon still to the right, you have three options (if you verify your YouTube account with a text message or phone call you can add your own custom images).
- 5. Select <u>publish</u> for your video to be seen.




## Using YouTube Videos on Your Website

- 1. Once your videos are published, click on your icon at the top right of the screen, and select <u>creator studio.</u>
- 2. Select the icon of the video you want to share on your website, click <u>view all</u> to see all of the videos you have created.
- 3. Under the video, click share. (Red arrow)
- 4. You can add videos to your website by using the direct link which is recommended (red circle), or the embed code.
- 5. If you are building a WordPress based website, you can use the direct link and post it directly to your website without any problems. WordPress will automatically convert the link to a playable video.


